Welcome to the new school year at Temple Adat Elohim Early Childhood Center 2019-2020. School will begin Wednesday, August 21. Our teachers are working on plans for an amazing year. Our teachers are looking forward to another engaging and fun year!

To provide the appropriate staff to student ratio, registration in advance is required. Priority enrollment is given to TAE members and currently enrolled students and their siblings. Space is limited to families who are current in their payments to both TAE ECC and Temple Adat Elohim. Please complete and return your registration form to reserve a space for your child.

Please review the school information below:

MORNING SNACK and LUNCH: Please provide snacks and lunch for your child(ren) daily. We find that this helps prevent allergic reactions and maintains the nutritional choice for each family. In compliance with TAE's kashrut (food laws) policy, please do not send shellfish or pork to school. For the safety of all children, **NO** peanuts and/or any other kind of tree nuts are permitted. Avoid items that "may contain" or are "made on shared equipment" with peanuts and/or any other kind of tree nuts.

DIAPER POLICY: Parents are required to provide diapers (labeled and appropriately sized for your child), wipes and adult medium size non-latex gloves.

STAY AND PLAY: Please provide a crib sized sheet to cover your child's mat along with a light blanket. Additionally, please provide a healthy afternoon snack in a clearly marked separate bag.

New Students to Temple Adat Elohim:

In addition to submitting the attached school registration form, new students must submit California State documents and other release forms for their school record. These documents are included in your welcome folder. *Please contact the ECC office if you do not have the documents so we can provide them to you..* **Please note, all records are kept confidential and are used to help keep the children safe. You will also receive a parking sticker to post on the lower left hand side of your car's windshield.

ADMISSIONS AGREEMENT 2019-2020

THE STATE OF CALIFORNIA LICENSING REQUIREMENTS STATE THAT WE MUST HAVE AN ADMISSIONS AGREEMENT WITH ALL CLIENTS OF OUR SCHOOL.

- 1) Admission shall be granted without discrimination with regard to religion, race or color. Our school is licensed by the State of California who requires us to fulfill their guidelines. Our teachers meet the standards of State Licensing as well as NAEYC and BJE accreditation standards.
- 2) Tuition is based on an entire 10-month school year, mid-August through mid-June. Below is the tuition schedule for **2018-2019**.

- 3) Member rates apply ONLY to Temple Adat Elohim Members who are current in their dues and fees.
- 4) Payment must be received by the 10th of each month. Each family must have a credit/debit card on file with authorization to charge the account if payment has not been received by the 10th of the month.
- 5) Your account must be current for continued enrollment.
- 6) **NO REFUND OR CREDIT WILL BE GIVEN FOR ABSENCES and CHILDREN MAY NOT SWITCH ONE DAY FOR ANOTHER DURING THE SCHOOL YEAR IN LIEU OF ABSENCES.** If a child does not complete the school year, tuition will be prorated based upon the number of months attended. In addition, **a one-month notice is necessary for a refund.** **Registration fees and Disaster fees are non-refundable.**
- 7) Late pick up after 6 p.m. will be charged \$20.00 flat fee plus \$5.00 per 15 minutes. (please initial)
- 8) THE STATE OF CALIFORNIA DEPARTMENT OF SOCIAL SERVICES REQUIRES THE FOLLOWING STATEMENT TO BE INCLUDED ON ALL ADMISSION AGREEMENTS.
 - a. The Department of Social Services, our licensing agency, shall have the inspection authority in regards to specified Health and Safety Codes.
 - b. The Department of Social Services shall have the authority to interview clients, including children or staff, and to inspect and audit client or facility records without prior consent. The licensee shall make provisions for private interviews with any clients, including children or staff members, and for the examination of all records relating to the operation of the facility.
 - c. The Department of Social Services shall have the authority to observe the physical condition of the client, including conditions which could indicate abuse, neglect, or inappropriate placement, and to have a licensed medical professional physically examine the client.
- 9) ***** **DIAPER POLICY** – Parents are required to provide diapers (labeled and appropriately sized), wipes and adult medium size non-latex gloves.
- 10) ***** **SNACK POLICY** – Parents must provide morning snack and lunch for their child(ren) daily. We find that this helps prevent allergic reactions and maintains the nutritional value of choice for each family.
- 11) PLEASE read the Parent Handbook, which you will receive with your new Student packet.
- 12) All documents (immunization record, state required forms, emergency card, payment Option, etc.) must be completed **before** your child can be admitted to school.
- 13) The school separation policy requires a parent or caregiver to stay or be available to stay with the child during the first full day of school. All changes in home or work phone numbers must be reported to the office immediately so parents can be reached in case of an emergency.
- 14) This agreement may be terminated when a child leaves Temple Adat Elohim ECC with a one-month written notice from the parent/guardian or from the school. A new agreement will be issued if modifications to the original agreement are necessary.
- 15) This agreement shall be dated and signed (on the reverse side) by the parent, legal guardian or his/her authorized representative **BEFORE** your child can be admitted to school.
