

#### Dear Parents,

Welcome to the 2020-2021 school year at Temple Adat Elohim! Our teachers are looking forward to an engaging and fun year! This year, in response to Covid, extra cleaning measures will be in place, hands will be washed very often, and teachers will be wearing masks and/or face shields. We kindly ask that all parents and guardians wear masks and practice social distancing when on the temple grounds. #### The first day of school will be on Monday, August 19.

To provide the appropriate staff to student ratio, registration in advance is required. Priority enrollment is given to TAE members and currently enrolled students and their siblings. Space is limited to families who are current in their payments to both TAE ECC and Temple Adat Elohim. Please complete and return your registration form to reserve a space for your child.

#### There are 3 school schedules for you to choose from:

- Monday-Friday 8am-1pm;
- Monday-Friday 8am-4:30pm;
- Monday, Wednesday, Friday 8am-1pm.

\*Please remember that the pre-kindergarten (Pre-K) and transitional kindergarten (TK) are 5 days/week programs.

#### Please review the reminders below:

- SNACK, LUNCH, and WATER BOTTLES: Please provide a water bottle, snacks, and lunch for your child(ren) daily. We find this helps prevent allergic reactions and maintains the nutritional choice for each family. In compliance with TAE's kashrut (food laws) policy, please do not send shellfish or pork to school. For the safety of all children, NO peanuts and/or any other kind of tree nuts are permitted. Food items that are "processed in a facility" with peanuts and/or any other kind of tree nuts are allowed. Avoid items that "may contain" or are "made on shared equipment" with peanuts and/or any other kind of tree nuts.
- **DIAPER POLICY:** If your child is not potty trained it is okay! Please provide diapers (labeled and appropriately sized for your child), wipes, and adult medium sized <u>non-latex</u> gloves.
- **CHANGE OF CLOTHES:** Preschool can get messy and potty accidents can happen. Please send an extra pair of clothes (including socks) with your children daily. You may keep a change of clothes in your child's classroom. Be sure to label all items.
- **NAPPERS:** If your child will be attending school until 4:30pm and naps, please provide a crib sized sheet to cover your child's mat along with a light blanket. Additionally, please provide a healthy afternoon snack in a clearly marked separate bag.
- **RISK AND WAIVER OF LIABILITY:** Please read, sign, and submit our Risk and Waiver of Liability PRIOR to the first day of school. Please email the signed document to <u>daustad@adatelohim.com</u>. The document is available at the end of this document and online <u>http://www.adatelohim.org/risk-liability-waiver</u>
- WELLNESS SCREENING: Each morning a wellness screening will be completed and temperatures will be checked. We recommend completing the wellness questionnaire before drop off each morning (leave temperature entry blank). We will have copies of the questionnaire available for you on campus as well. The wellness screening questionnaire is available at the end of this document or online www.adatelohim.org/WellnessScreening

THE STATE OF CALIFORNIA LICENSING REQUIREMENTS STATE THAT WE MUST HAVE AN ADMISSIONS AGREEMENT WITH ALL CLIENTS OF OUR SCHOOL.

- Admission shall be granted without discrimination with regard to religion, race or color. Our school is licensed by the State of California who requires us to fulfill their guidelines. Our teachers meet the standards of State Licensing as well as NAEYC and BJE accreditation standards.

- 3. Member rates apply ONLY to Temple Adat Elohim Members who are current in their dues and fees.
- 4. Payment must be received by the first day of each session.
- 5. Late pick up after 4:30 p.m. will be charged \$20.00 flat fee plus \$5.00 per 15 minutes.
- 6. THE STATE OF CALIFORNIA DEPARTMENT OF SOCIAL SERVICES REQUIRES THE FOLLOWING STATEMENT TO BE INCLUDED ON ALL ADMISSION AGREEMENTS. a) The Department of Social Services, our licensing agency, shall have the inspection authority in regards to specified Health and Safety Codes. b) The Department of Social Services shall have the authority to interview clients, including children or staff, and to inspect and audit client or facility records without prior consent. The licensee shall make provisions for private interviews with any clients, including children or staff members, and for the examination of all records relating to the operation of the facility. c) The Department of Social Services shall have the authority to observe the physical condition of the client, including conditions which could indicate abuse, neglect, or inappropriate placement, and to have a licensed medical professional physically examine the client.
- 8. DIAPER POLICY: Parents are required to provide diapers (labeled and appropriately sized) and baby wipes.
- 9. SNACK POLICY: Parents must provide morning snack and lunch for their children daily. We find that this helps prevent allergic reactions and maintains the nutritional value of choice for each family.
- 10. NON-LATEX GLOVES: Each family is required to supply 1 box of adult, size medium, non-latex gloves per session.
- 11. SAFETY PLAN: Must be read prior to submitting the registration form and signing the admissions agreement. https://www.adatelohim.org/ECC-Safety-Plan-2020
- 12. All documents (immunization record, state required forms, emergency card, payment option, etc.) must be completed before your child can be admitted to school.
- 13. The school separation policy requires a parent to be available for pick up as needed. All changes in home or work phone numbers must be reported to the office immediately so parents can be reached in case of an emergency.
- 14. Force Majeure: Should events beyond the control of TEMPLE ADAT ELOHIM, including, but not limited to, any fire, act of God, hurricane, tornado, flood, extreme inclement weather, explosion, war (including armed conflict), governmental action, act of terrorism, risk of infectious disease, epidemic, pandemic, shortage or disruption of necessary utilities (water, electricity, etc.), or any other event beyond TEMPLE ADAT ELOHIM's control, occur, TEMPLE ADAT ELOHIM has the discretion to close TEMPLE ADAT ELOHIM and/or modify its curriculum, schedules, length of school day, length of school year, and/or means of learning and teaching methods. Should TEMPLE ADAT ELOHIM close, TEMPLE ADAT ELOHIM's duties and obligations under this Contract shall be suspended immediately without notice until such time as TEMPLE ADAT ELOHIM, in its sole and reasonable discretion, may safely reopen. If TEMPLE ADAT ELOHIM cannot reopen due to a force majeure event under this Paragraph, TEMPLE ADAT ELOHIM is under no obligation to refund any portion of any fees, deposits, or other amounts paid. In the event that there is a confirmed case of COVID-19 case among the children or staff, and your class or the school needs to close for up to fourteen days tuition will not be refunded. In the event that TEMPLE ADAT ELOHIM we be closed more than 14 days, we will adjust tuition based on the educational model the school can provide the children.
- 15. A new agreement will be issued if modifications to the original agreement are necessary

This agreement shall be dated and signed (on the reverse side) by the parent, legal guardian or his/her authorized representative **BEFORE** your child can be admitted to school.

# ECC Coronavirus/COVID-19 Child Waiver

## ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-toperson contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

Temple Adat Elohim has put in place preventative measures to reduce the spread of COVID-19; however, TAE cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending TAE or TAE-related activities could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending TAE or TAErelated activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at TAE or TAE-related activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, TAE employees, volunteers, and TAE-related activity participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at TAE or participation in TAE-related activities ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless TAE, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of TAE, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any TAE-related activity.

I understand and agree that the law of the State of California will apply to this Waiver of Liability. I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS WAIVER OF LIABILITY, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE:
