## **RAD Parade Rules and Guidelines**

Please note that all guidelines will be enforced for the safety and enjoyment of everyone. Agency Parade Monitors will be placed throughout parade route. Those in violation of rules and regulations or that risk the safety of others will be escorted off parade route and may be prohibited from participating in future parades. The direction of Parade Officials should be followed. The Agency, Agency Fire Department, Agency Police Department, and any other authority having jurisdiction over the parade, reserve the right to issue a warning to the Parade Applicant or its Participants, to order correction of non-compliance at any time before or during parade, or to remove from the parade any person, float, or vehicle from the parade that fails to comply with parade rules and guidelines. ### **Parade Information and Line Up:**

- Pre-registration is required for participation in the parade. Parade entry applications will only be considered if submitted by **Friday, September 23, 2022**. You will be notified by email when your entry has been approved.
- Parade Route: approximately one mile and begins at the intersection of Reyes Adobe Rd. and Lake Lindero Rd. and proceeds to the Historic Reyes Adobe and park.
- The person completing the parade entry application must check-in their parade entry the day of the parade. Check-in area will be located at **Yerba Buena Elementary School** on **Saturday, October 8, 2022**.
- All parade entries must arrive at the staging area located at Yerba Buena Elementary School no later than 9:00 a.m. **Please note, only vehicles that are physically in the parade will be allowed in the staging area.** No entries will be allowed after this time.
- Parade participants enter the staging area by traveling north on Lindero Canyon Blvd. from the 101 Freeway. Once past Thousand Oaks Blvd., you will be turning into the Yerba Buena Elementary School parking lot on your right side. Please note, only vehicles that are physically in the parade, will be allowed in the staging area. There will be a drop off area immediately after parking lot for all other participants. When directed by Parade Officials, all participants will travel to entrance of Yerba Buena Elementary School and line-up. Parade Officials will then direct your party into parade route.
- A representative of vehicle/float entry must remain with the vehicle/float once in parade lineup, in the event it needs to be moved or repositioned.
- It is at the sole discretion of Agency Parade Officials to deny participation in the parade to any entrant, apparatus, vehicle, or attire/costume, etc. deemed unsuitable and unsafe to participants and spectators. Participants' registration fee is non-refundable. (if applicable)

### **Parade Participants:**

- Parade entry applicant is responsible for ensuring that all entry participants read and comply with all Parade Rules and Guidelines.
- Every participant in an entry must sign a Parade WAIVER, RELEASE, HOLD HARMLESS AGREEMENT. In the case of minor participants (under 18 years of age), a parent or legal guardian must sign the waiver. Please make copies of the waiver and assign someone from

your organization to collect and turn in the waivers at check-in, if you do not enclose them with your parade entry application.

- For the protection of spectators and parade participants, throwing of items along the parade route and towards spectators (ex: candy, toys) is prohibited. Any giveaways must be handed directly to parade attendees by walkers along the route. Distribution of giveaways must be approved by Parade Officials.
- Parade participants are not permitted to ride on floats as they are being transported to and from the parade site.
- Children are not permitted to ride on a float without adult supervision.
- Children age 13 and under, must be accompanied by an adult (18 years or older) when riding in a vehicle. Children must be properly secured in a car seat or with a seatbelt.
- Entries with minor participants are required to have at least one adult for every ten children, unless otherwise waived by Parade Officials. Adults shall supervise children during the parade.
- Participants are not allowed to ride on any section of a vehicle, including fire vehicles, which are not designated for the safe transportation of riders.
- Participants must remain on their float or vehicle during the entire parade, regardless of whether the float or vehicle is in motion or has temporarily stopped.
- All passengers standing or sitting on a float should wear a safety belt, have handholds, or other support while the float is moving.
- Participants shall not cling to or ride on the outside of a float or vehicle at any time, regardless of whether or not the float or vehicle is in motion.
- Participants are not allowed to ride on the edge of floats.
- Any participant riding a bicycle, scooter, or other wheeled apparatus must wear a helmet.
- Participants shall keep up with the pace of the parade and vehicles in the parade. Performers shall not perform in any matter that causes a temporary or permanent stopping or slowing of vehicles in the parade. Parade entries must continue moving until reaching the disband area.
- Starter pistols, fireworks, and cannons are prohibited. The level of amplified music and sound effects will be moderated to avoid startling animals and/or drivers in the parade.
- Consumption of alcoholic beverages and illegal substances are prohibited.
- Parade participants and spectators are subjected to photographing/videotaping that may be used for future advertising and/or social media.

### **Float Vehicles (if applicable):**

- Open flame devices are not allowed on parade floats. Use of fuel fired torches, candles, or other similar devices are prohibited.
- Smoking is prohibited on or near any float.
- All decorative material used on floats must be flame resistant.
- A portable fire extinguisher should be available on each float.
- Float vehicles should be properly serviced prior to entry into the parade. No extra gasoline (other than in the vehicle's tank) should be carried on the float vehicle.
- Decorative material should be kept clear of the exhaust system of a motorized float.
- Any portable generators should be secured to the parade float. Refueling of generators along parade route is prohibited.

- Any electrical systems used during the parade are required to be in good condition and in complete legal working order. Bare wires or exposed electrical connections are not permitted.
- Float beds should be structurally sound and safely designed, capable of carrying the weight of equipment and participants. Floats must include emergency exits for all riders and sufficient ventilation for the removal of vehicle power and exhaust.
- The length, height, and width of floats to dimensions that accommodate the parade route's street widths, turns, overhanging branches, and bridge clearances.
- The driver of the float vehicle should have a wide, unobstructed field of view.
- All trailer hitches and connections to a vehicle shall be in good condition and in complete legal working order on the date of the parade, and shall comply will all applicable laws and standards. Primary and secondary connections shall be appropriate for the normal and anticipated loads.

### **Vehicle Entries/Drivers:**

- Vehicle operators are not permitted to perform special maneuvers such as "burnouts," "doughnuts," weaving along parade route or towards spectators, or racing between points. Any such action will warrant immediate removal from parade and law enforcement will be notified.
- The speed of motorized units shall be limited to **5 or 10 mph**.
- Drivers shall minimize abrupt starts and stops.
- Drivers must maintain a distance of **50 feet** from the preceding unit. Special attention shall be given to maintain a safe distance from all walkers and performers.
- A 180 degree unrestricted view is required for all drivers. If a 180 degree view cannot be provided to the driver, one or more spotters with a clear vision of all obstructed areas shall be in or on the vehicle or trailer at all times during the parade, and shall act as a guide for the driver.
- Appropriate driver communication should be maintained at all times throughout the parade.
- All motor vehicles in the parade must be inspected by the fire/police department prior to the start of the parade.

### **Animals in Parade:**

- All animals included in the parade must be listed on the parade application. Any approved animals are required to have updated vaccinations, be in good health, and capable of coping with other animals and large crowds.
- Adequate space will be placed between participants that generate noise (ex: emergency vehicles, marching bands, etc.) and animals participating in the parade.
- Horses, mules, or dog entries must provide clean up units to follow directly behind entry.

### **Disbanding**

- There will be a traffic pattern at the end of the parade for the disbanding process.

The parties to this agreement understand that this document is not intended to release any party from any act or omission of "gross negligence," as that term is used in applicable case law and/or statutory provision.

In consideration for being permitted to participate in the event, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify, defend, and hold harmless City of Agoura Hills Parks and Recreation Department from any and all claims, demands actions or suits arising out of or in connection with my participation in the event.
